PUBLIC ANNOUNCEMENT

Pyramid Lake Paiute Tribe - Indian Community Development Block Grant

On behalf of the Tribe, the Housing Authority is accepting new applications for a one-time Furnace & Central Air Project.

This Project will follow the requirements of the NAHASDA-Housing Authority. You will need to pick up an application and submit all the required documents. Once the application is received in the office, it is date stamped and the time and staff initials are listed on the application. The application is added on a numerical list and this is how we provide the assistance, according to the list.

1. List all family/persons living in the household on a permanent basis (more than 6 months considered a permanent family member). Signatures needed for all over 18 yrs and over.
2. Provide copies of State issued driver's license and/or PLET Tribal ID.
3. All persons listed under 18 years of age need a copy of the birth certificate.
4. Provide copy of the income, earned or unearned. Example: disability, social security, pers retirement, etc.

All applicant information is verified by third party conformation, so please provide copies and/or as much information as you can to verify the income. We try to assist as many participants as funds allow.

The Program is based on income, below is the income levels with family compositions. If you're located in the various income levels, each applicant is provided a chance to be included in the project. You may need to pay 20% of the cost for 80%-100% income level. For 100% and above income levels the cost will be full price.

ICDBG: Central Air and Furnace Replacement Project

All Tribal eligible applicants must complete the Housing Authority application for the Program. The applicant must live in the home and be the primary residence in order to qualify for the project.

"Who Can Apply?"

Tribal member as the head of household who is an enrolled member of the Pyramid Lake Paiute Tribe. Must be permanent residents and meet the NAHASDA guidelines.

Photocopies of necessary documents are acceptable but MUST contain current information.

Household Application Information:

Applies to: Applicant, spouse and all permanent members residing in household o Verification must be documented by a photocopy of a Tribal Membership Card or Certification of enrollment from the Tribal enrollment Department.

"How long does the application process take?"

Once all forms and essential information is completely submitted to the Housing Authority, third party verifications will be sent to your employer/agency to ensure that you qualify for the program.
